## **Electrical Inspections**

The Village of Croton-on-Hudson Building Department requires a certificate of electrical inspection to be submitted for all electrical work associated with a building permit, prior to a certificate of occupancy being issued. It is the Applicant's responsibility to ensure that the building department receives the certificate of electrical inspection.

Chapter 113 of the Village Code (entire code available on the web site) also requires that all electrical work be inspected by an approved agency and a certificate of approval issued prior to connecting the new work to a source of electrical energy. This includes electrical work not associated with building permits.

In Westchester County all electricians (with some exceptions e.g.: Con Edison) must be licensed by the County. A list of County-licensed electricians can be obtained from the Westchester County Clerk and is also available on the County's website.
