

VILLAGE OF CROTON ON HUDSON

RULES AND REGULATIONS FOR THE CROTON HARMON STATION PARKING LOT

1. THE VILLAGE OF CROTON ON HUDSON IS NOT RESPONSIBLE FOR THE THEFT OR ANY FORM OF VEHICLE DAMAGE WHILE A PATRON IS PARKED IN THE MUNICIPAL LOT.
2. PARKING PERMITS ARE NON-TRANSFERABLE, AND ONLY VALID FOR THE LICENSE PLATES THAT ARE ON FILE WITH THIS OFFICE. THE PERMITS MAY NOT BE COPIED AND ARE NON-REFUNDABLE. THE PURCHASER IS WHOLLY AND FULLY RESPONSIBLE FOR PERMITS PURCHASED. THERE WILL BE NO COST-FREE REPLACEMENTS FOR PERMITS LOST, STOLEN, DAMAGED OR NOT DELIVERED BY THE U.S. POSTAL SERVICE. A REFUND WILL BE GRANTED FOR UNUSED PERMITS RECEIVED IN THE VILLAGE OFFICE BEFORE THE FIRST DAY OF THE MONTH PRINTED ON THE PERMIT. THERE IS A \$10.00 REFUND PROCESSING FEE.
3. PARKING IS ON A FIRST-COME, FIRST-SERVE BASIS.
4. ALL INFORMATION ON FILE WITH US MUST BE KEPT CURRENT. A CURRENT COPY OF THE CAR REGISTRATION FOR EACH CAR YOU LIST WITH US MUST BE ON FILE IN THIS OFFICE AND EVERY TWO YEARS WHEN YOU RENEW THE REGISTRATION WE NEED A COPY. YOU CAN FAX THE COPY TO US AT 914-271-2836. VILLAGE RESIDENTS MAY ALSO BE REQUIRED ANNUALLY TO PROVIDE PROOF OF RESIDENCY.
5. CERTAIN AREAS ARE DESIGNATED BY SIGNS "RESIDENT PARKING ONLY" NON-RESIDENT PATRONS PARKING IN THESE AREAS WILL BE SUMMONED.
6. RESERVED PERMITS ARE VALID ONLY IN THE "RESERVED PARKING BY SPECIAL PERMIT ONLY" AREA. NO OTHER PERMITS ARE VALID IN THIS AREA.
7. PERMITS MUST BE DISPLAYED WITH THE SILVER SECURITY BAR FACING OUT. FAILURE TO DO SO WILL RESULT IN A SUMMONS. INSERT PERMIT IN PLASTIC HOLDER PROVIDED. ATTACH IN A VERTICAL POSITION TO THE INSIDE LEFT PASSENGER WINDOW. SEE DIAGRAM BELOW.
8. ONLY THE PERMIT FOR THE CURRENT MONTH IS TO BE DISPLAYED. PURCHASERS ARE RESPONSIBLE FOR DISPLAYING THE PROPER PERMIT TO AVOID BEING SUMMONED.
9. NON-RESIDENT AND RESERVED PERMITS MUST BE PURCHASED CONSECUTIVELY IN ORDER TO REMAIN ACTIVE. MISSING MONTHS MUST BE PURCHASED IN ORDER TO RESUME ACTIVE STATUS.
10. PERMITS MAY BE PURCHASED IN ADVANCE FOR UP TO TWELVE MONTHS BUT, WITHIN THE VILLAGE'S FISCAL YEAR - JUNE 1, THROUGH MAY 31.
11. CHECKS ARE MADE PAYABLE TO: VILLAGE OF CROTON ON HUDSON. THERE WILL BE AN ADDITIONAL CHARGE OF \$20.00 ON ALL RETURNED CHECKS.
12. RENEWAL INSTRUCTIONS APPEAR ON THE BACK OF THE RENEWAL STUB ATTACHED TO EACH PERMIT.
13. METERED PARKING IS AVAILABLE IN THE RIGHT REAR UPPER PARKING LOT. SIGNS ARE POSTED PERMITS ARE NOT VALID IN THE METERED SPACES.
14. ALL HANDICAPPED PARKING SPACES ARE METERED. PERMITS ARE VALID IN METERED HANDICAP SPACES, WHEN ACCOMPANIED BY A NEW YORK STATE PERMIT FOR THE DISABLED.
15. THE JUSTICE COURT PERSONNEL WILL REVIEW OUTSTANDING TRAFFIC TICKETS. ALL OUTSTANDING TICKETS ISSUED IN THE VILLAGE OF CROTON ON HUDSON MUST BE RESOLVED BEFORE A PARKING PERMIT WILL BE ISSUED.
