Brief Description of Proposed Action: Acceptance of a gift of property located at 1300 Albany Post Road from Laurel Gouveia in accordance with terms of the Term Sheet (attached). The property consists of 15.69 acres and will be used by the Village for passive recreation. The initial use of the property would involve the creation and use of trails on the southern wooded portion of the property which contains the intermittent streams and occasional use of other portions of the property for educational and Village sponsored events. Trails would be created only by trimming branches on trees and shrubs and removing brush. Over time Village use of the property would be for passive educational uses such as hiking, picnicking, music events and exhibits, environmental education, senior citizen and other club meetings. If additional parking is required during these events temporary parking will be available on the lawn area. No additional paved or gravel parking areas are planned.
