Requirements for inspection of fuel gas line/service:

- Specs of all equipment to be installed must accompany this application or web address (URL) for documents.
- Location of equipment, gas lines and tanks, if applicable, must be shown on a survey or scaled drawing.
- Proof of insurance –for outside work, (Liability, Disability & Workers Comp) must be submitted with Village of Croton on Hudson named as secondary insured. Insurance not required for licensed plumber.
- Copy of installer's Westchester County License and/or Westchester County Plumbers License.
- If gas line is to be placed in a trench, an inspection is required prior to back filling of the trench.
- Final inspection/pressure test must be completed by the Plumbing Inspector. Please call 914 271-4783 to schedule an appointment.

Requirements for permanent installation of a whole house natural gas generator/propane tank generator:

- At least five (5) feet from openings in walls and structures having combustible walls, with the exception of the following:
 - *The adjacent wall of the structure has a fire resistance rating of at least 1 hour*
 - *The weatherproof enclosure is constructed of noncombustible materials and it has been demonstrated that a fire within the enclosure will not ignite combustible materials outside the enclosure.*
- Install according to manufacturer's instructions.
- A copy of the equipment specifications and installation instructions or web address (URL) for these documents.
- Location of equipment and gas line provided on a survey, plot plan or scaled drawing.
- Generator shall be supported on foundation or secured to a noncombustible framework.
- Pressure testing of gas piping must be completed by the Plumbing Inspector; call our office at 914 271-4783 for an appointment.
- Installed by a Westchester County licensed plumber & electrician. (Exterior underground gas line for liquid propane installation from a supply tank(s) does not require a licensed plumber. Any gas line work inside a structure requires a licensed plumber).
- Electrical certificate must be sent to the Village Engineer's office – 1 Van Wyck Street, Croton on Hudson, NY 10520.
- If an option, a residential muffler is recommended.
- Be respectful of neighbors and install the generator some distance from the property line; the middle of the property or 5 feet from the property line is recommended.

Note: No permit is necessary for generators not permanently installed (portable unit)

- Please follow manufacturer's instructions.
- Keep generator away from the house. Never run a portable generator inside a building.
- If an option, a residential muffler is recommended.
- Be respectful of neighbors – the recommended location for the generator is as far as possible from the neighboring house.

The proposed work outlined conforms to all provisions of the laws of the Village of Croton-on Hudson and laws and codes of the State of New York and the work will be performed in accordance with provisions of such laws and codes.
