2016 Village Projects

Comprehensive Plan Update

A Comprehensive Plan is a document designed to guide the future actions of a community. Croton-on-Hudson's existing Comprehensive Plan was developed by the Comprehensive Plan Committee over a number of years and adopted by the Village Board of Trustees in 2003. The 2003 Plan is still in effect, and it is expected that the approval for the 2016 update will be completed in the upcoming months. The 2016 Comprehensive Plan outlines long term goals and objectives for all aspects of the Croton community. The 2016 Comprehensive Plan includes four main goals as the Village's vision for the future:

- 1. Enhance the Village's visual environment and public areas using design guidelines, improved streetscapes, code enforcement, as well as enhancing commercial vitality.
- 2. Upgrade the Village's pathways for pedestrians and bicyclists, and improving parking and traffic flow. (The Elliott Way Improvement Project is an example.)
- 3. Develop a consistent way finding signage program to include directional signage, promote commercial areas, cultural activities, and Village assets.
- 4. Update and promote the Village's identity and brand to celebrate Village history, culture, diversity, and natural resources.

This Comprehensive Plan should be in effect for years to come and includes specific ways the Village plans to meet these goals. A draft of the 2016 Plan is available on the Village website's main page under "Quick Links."

The Elliott Way Improvement Project

For a number of years, the Village has been exploring the options for improving the connection between Senasqua Park and the Croton Yacht Club. The Village's engineering design consultant, Site Design, has designed the plans and specifications for an elevated walkway which will allow pedestrians a separate walkway between the two sites. Currently, walkers, runners, strollers, dog walkers, bicyclists, and vehicles, must share the narrow stretch of a single lane road. In addition to the elevated walkway, the project also includes an additional sidewalk extending from the Elliott Way walkway north through the edge of Senasqua park, the replacement of an existing corrugated metal arch pipe, replacement of an existing sediment basin, as well as shoreline rehabilitation and protection. Work is expected to begin this fall. More information on the project is available on the Village website under "Projects and Initiatives."



Corrosion Control

The Village of Croton-on-Hudson is dedicated to producing drinking water that meets all State and Federal standards, and continually strives to adopt new methods for delivering the best quality drinking water to your homes and businesses. Within the last few years the Village has been experiencing increasing levels of copper and the Westchester County Department of Health has mandated the Village to introduce a corrosion control additive to the Village's water supply.

The Chazen Companies, a firm which provides engineering, land surveying, planning, environmental, and safety services to clients throughout the Northeast and beyond, have recommended adding a blended phosphate to the water distribution system. Based on the specific chemical makeup of our water supply, the chemical Carus 8600 has been recommended. This chemical is very commonly utilized in the potable water industry as well as the food industry and has Kosher approval. Additionally, it is expected to perform well without the need for any other chemicals.

This additive will limit the corrosion of pipes and leaching of copper, iron, and lead in the water. It is also expected to reduce the frequency of brown-water events. 3.2 gallons of Carus 8600 will be injected for every million gallons of water sent into the distribution system. While this dosage may seem small, the distribution system is expected to be coated in about a week's time.

Before the addition begins, a few general improvements must also be made. These include: a new climate controlled weatherproof structure, a chemical feed pump system, insulated chemical feed lines, (2) double-walled

bulk storage tanks, and small site improvements to accommodate the structures. Having recently been approved by the Westchester County Department of Health, the project is expected to begin this fall.



The Croton Dummy Light

Most residents of the Village are familiar with one of our local landmarks located at the intersection of Old Post Road South and Grand Street—the traffic light that stands on a pedestal in the middle of the intersection, better known as the "dummy light." Don't worry, this historically valuable piece won't be going anywhere. In fact, the Village has just recently spruced up the brick work and added some structural reinforcement. However, you can expect a more noticeable change coming this September. Instead of

functioning as a streetlight, the Village intends on having it blink red in all directions as a three-way stop. This is expected to improve pedestrian safety as well as traffic flow.

POLICE



The Croton PD Cadet Program

The Croton Police Department runs a Cadet Program for residents of the Village ages 13 to 18, who have an interest in Law Enforce-

ment. Cadets meet every other Wednesday during the school year for two hours. The Program exposes Cadets to all aspects of Law Enforcement, provides basic training, and instills an appreciation for the police function in the community. Instructed topics range from Criminal Law to First Aid to the Court System and more.

Agents and officers from other agencies are often guest speakers at meetings. Cadets learn about a variety of units and services within the Department as well as other departments in Westchester County.

Young adults in the Program also have opportunities to assist the Police Department with community events. The year culminates at Stations Day, a competition at the Westchester Police Academy where Cadets from all over Westchester County compete in responding to different scenarios as if they were officers on scene. Community Safety Initiative

One thing that makes Croton-on-Hudson unique is that virtually every road in the Village runs through a residential area. Additionally, many are very narrow and require extra caution. With that in mind, we have a greater responsibility when it comes to driving, riding, and walking in the Village. Because the Village is committed to maintaining a safe traffic environment and preserving our community's quality of life, a two-pronged initiative will begin this September to increase community safety.

The Village will begin a "Slow Down, Croton" campaign, supported by the Croton-Harmon School District's "Safe Routes to School" campaign. This initiative strives to make community members aware of the need to enhance safety measures throughout the Village. The initiative will begin with the following measures:

- 1. Increased traffic enforcement throughout the Village.
- 2. Informational presentations for students and community organizations. Presentations will also be given for residents at the September 1st Board of Education meeting and the September 6th Board of Trustees meeting.
- 3. Conducting safe walks to school with fifth and sixth grade students. Also called "Safety Always Matters" field trips, school and village representatives will accompany students walking to school, while identifying dangerous and avoidable practices and behaviors.
- 4. Grassroots marketing efforts by Village residents.
- 5. Continued campaign efforts throughout the year.

While efforts will be made to educate students in being responsible pedestrians, the Village also strives to remind drivers of some important things to remember while on the road:

- 1. The Village speed limit is 30 mph; leave early so you're not in a rush!
 - 2. Always yield to pedestrians.
- 3. Text messages can wait until the end of your ride.

- 4. Come to full stops at Stop Signs.
- 5. Be aware of kids.
- 6. Respect bicyclists; they've got a harder ride!
- 7. Engage in stress relieving activities to avoid road rage.
