

"Love 'Em and Leave 'Em" Instead of dragging leaves and grass clippings to the curb for pick up, the Village encourages you to preserve nature's valuable resources by leaf mulching. Homeowners and landscapers can simply mow over the leaves and grass clippings where they fall to produce a free and natural fertilizer. This process is easier and faster than dragging leaves and grass clippings to the curb, but additionally reduces expenses and pollution from vacuuming leaves and exporting them out of the Village. For those who choose not to participate, a weekly street schedule for leaf vacuuming will be posted on the Village website in November.

Utility Billing

On May 1, 2017, the Village's Board of Trustees adopted Local Law 3 of 2017, which will change utility billing from biannual to quarterly. The increased billing periods will allow residents to more closely monitor their water consumption in an effort to identify and fix issues that could lead to abnormally high utility bills. The next bill will be mailed September 15, 2017.

Place Update

The water and sewer improvement project on Farrington Road and Hunter Place has progressed on schedule and is still anticipated to be completed in October. This project will improve water quality through the replacement of water mains, update of the sanitary sewer system, and the replacement of cracked and aging sidewalks and curbs, concluding with the repaving of streets.

Hydrilla Update

The NYS Department of **Environmental Conservation** (NYSDEC) will continue to treat the hydrilla infestation. The application of the aquatic herbicide fluridone is intended to control the growth and spread of the highly invasive aquatic plant and reduce the hydrilla's long term impacts on recreation, ecology, and water quality in the Croton River. The NYSDEC website (search "Croton River" on the main page and select the first link) provides information regarding treatment updates and test results from water samples. The next public session on the hydrilla treatment will be held Januarv 24th at 6:30pm in the Stanley H. Kellerhouse Municipal Building. Residents can call the Village Manager's office at 271-4848 with additional questions.



Corrosion Control Update

Work has been completed on the building housing the corrosion control system, and chemical feed pumps along with other equipment are being installed and will soon be integrated with the supervisory control and data acquisition (SCADA) system, which monitors **DPW Building Update** and controls the equipment. It is anticipated that the corrosion control system will be certified with the Westchester County Department of Health and receive approval to be activated in October. The blended ortho/poly phosphate, without zinc, will be injected into the water supply to limit the corrosion of pipes and leaching of copper. This will also reduce levels of iron and lead in the water. The Village will continue to provide updates on this project and strive to provide the best quality drinking water to vour homes and businesses.

Farmers Market

The Croton-on-Hudson Farmers Market is still open until

November 19th from 9am to 2pm on Sundays in Section A of the Croton-Harmon train station parking lot. A map of the station with labeled sections is available on the Village website under "Train Station Parking" for additional clarification.

The Village has been inspecting the properties at 435 and 439 Yorktown Road in the Town of Cortlandt, and at this time plans to move forward with relocating the Department of Public Works (DPW). The Village believes this move will consolidate the location of DPW staff, create a more efficient operation, ensure a longer life for Village vehicles and equipment, as well as create a safer environment for workers. The decommissioning of the previous DPW facility would also create 150 commuter parking spots at the Croton-Harmon train station. generating an annual \$150,000. It is expected that a final decision will be made at the Septem-

Elliott Way

This project is designed to complete the section of River-Walk from the northern end of the Senasgua Park parking lot to the entrance of the Croton Yacht Club. This RiverWalk segment includes an 8'10" wide sidewalk protected by a seawall, as well as an elevated boardwalk in the marina area of the yacht club. The shoreline protection and road drainage portion of the project is nearly complete, and will be followed by the installation of sheet piling and a sedimentation basin for water quality improvement and helical piles for the boardwalk. One lane traffic will continue to be regulated by automated flagmen and is limited to vehicles and bikes. These automated flagmen are not programmed for pedestrian travel speeds, but pedestrians are still able to access Croton Landing Park via the Pedestrian Bridge.
