# Improving Transparency of Village Board Meetings

Since the 1990's, when the Village began televising its Village Board meetings, there have been successive improvements in making the Board's deliberations more accessible on many levels. While the televised meetings enabled people with cable television to watch from home on Channel 78, the meeting was only available for viewing on one other night dur-

ing that week.

To make the Village Board meetings continuously available, livestreaming began in June of 2006. Residents with online computer capability were able to access meetings at their convenience. They could also skip to the parts of the

meeting they were interested in seeing rather than watching from the beginning.

New video system will

To prepare for meetings, the Trustees receive agendas containing correspondence and draft resolutions with relevant back up documents for the agenda items requiring their action. Although the subject matter was made available in advance to the general public, the backup material In 2011 a software package, was not. NOVUS Agendas, was introduced. NOVUS allowed all the documents relevant to an agenda item to be available online to all residents from the Village's website. The resulting meeting minutes are also subsequently posted on the website. Making the backup information available to residents for Village Board agenda items enabled residents to have a clearer understanding of the information available and the proposed wording for resolutions. It also helped interested residents to prepare their remarks at Board meetings based on the information.

While attending a meeting, however, those in the audience are frequently at a loss in understanding the discussion because they don't have the documentation in front of them. Lengthy resolutions, in particular, pose a challenge for attendees to follow as they are being read as well as references to particular documents being referred to by the Trustees.

To improve this situation, the Village has recently installed two large television screens facing both the audience and the Trustees which will display the documents being discussed by the Trustees. These documents will also be fed to the live-stream feed for people viewing from their computers. Several small video cameras mounted on the wall such as the

one seen over the dais in the accompanying picture will record the Board, speakers during Citizen Participation segments, and the audience for a more complete experience for the home viewer. The video camera seen

in the picture on the left will no longer be in use as the camera operations will be managed mainly from the control room in the rear of the room. This new system, intended to enhance the viewing experience for both the viewer in the audience and the viewer at home, is expected to be initiated at the November 5 Board meeting. A single monitor system with the same capabilities is installed in the small conference room where the Board holds its work sessions.

Specific topical presentations will also be enhanced for the audience and the home viewer through greater clarity of the presenter's pictures and charts.

### **Vincent Van Ghost Wins!**


This year's Grand Prize winner in the Halloween Win-

#### **Recreation News!**

Summer 2012 marked another successful season for Croton's Recreation Dept. The numbers of attendees at various programs and facilities was impressive.

Silver Lake had a amazing total attendance of 9,655 over its summer season! The Friday night concerts at Senasqua Park continued to be popular with 200 to 600 attendees

per concert. The Wednesday evening movies, also at the park, had an attendance ranging from 50 to 150 people.

The three two-week sessions of Day Camp averaged 65 to 75 per session. Half-day Tiny Tots Camp

had 3 to 45 per session while full-day Tiny Tots Camp had 13 to 24 per session.

**Fall Programs.** The full schedule of programs, begun in September and October are continuing into Novem-



ber. Two additional classes, offered through the Recreation Dept., will be held in November. Introduction to Coastal Navigation and Coastal Navigation Certification will be offered for the second year. The Introductory

course (I-day, Nov. 4, 12 noon to 5 pm) teaches navigation techniques for sailing in coastal or inland waters including piloting, dead reckoning and reading charts. The Certification course (3 days, Nov. 4, 10 and 11, 12 noon to 5 pm) provides additional information such as correcting course for currents and leeway and tide/tidal currents. It culminates with the American Sailing Assoc. certification test. The registration deadline is Nov. 4. #### **Lifeline Discount Phone Service**

Lifeline and Linkup Telephone Service are 2 government assistance programs that provide income-eligible custom-



# Got a Question?



I have Verizon service for phone and internet and would like to upgrade to FIOS service for tv as well. Is it true that Verizon is not planning to offer this service in Croton.

Unfortunately the answer is 'yes'. Verizon has confirmed at a conference of investors at Goldman Sachs in September, that it will not be expanding their FIOS services any further beyond their current franchise obligations. Verizon is moving away from wired networks to wireless.

The Village first invited Verizon to negotiate a franchise in 2007. After a series of starts and stops, Verizon called off negotiations in March, 2010. This also occurred with similar negotiations in other County municipalities.

Many residents contracted for phone and internet services in anticipation of getting its FIOS television service as well. Verizon's decision has left many of their Croton customers unhappy and confused about not getting the service they anticipated.

## The Energize Croton Program

On November 29, at 7:30 pm, at the Croton Library, Croton's Sustainability Committee will present a program to publicize and inform local organizations and residents about the benefits of the Energize Croton Program.

The Village Board voted to participate in the Energize New York program in order to extend the residen-



tial energy efficiency program to Croton residents.

A key component of the program, which the Village joined, is the inclusion of a public outreach component. The New York State program has been in existence for many years but, without a program that successfully publicizes it, has a low participation rate. The local Energize program, piloted by the Town of Bedford, seeks to increase participation through outreach to local organizations and community groups. Croton has designated the Sustainability Committee to manage the outreach to these groups as well as residents.

The meeting at the library will enumerate the many benefits and resources available through participation in the Energize program. The many groups who will be invited are expected, in turn, to pass on the Energy Program information to their constituents - increasing awareness of the program, its benefits, and participation in it.

Currently 13 of the 14 Northern Westchester Energy Action Consortium (NWEAC) municipalities participate in the program. Individual residents can qualify for energy audits by licensed contractors at no cost to them in most cases. (It is free for households with incomes under \$210,000). Twenty-five residences in Croton have already taken advantage of the program and more are expected to sign on with increased knowledge of its benefits.

The free, or low cost, energy audit will result in a report which identifies improvements that would increase energy efficiency and reduce energy costs. A homeowner who decides to go ahead with the suggested improvements can participate in a low rate financing plan and may be eligible for 10% to 50% rebates on the costs. The average cost of improvements suggested as a result of an authorized Energy Audit is \$11,000 to \$12,000. The homeowner can decide whether or not to implement the suggested improvements or select which ones to undertake.
