Village Budget Summary

On March 20, 2017, Village Manager and Chief Budget Officer, Janine King, filed the tentative budget for fiscal year 2017-18. This budget is a result of submissions from and discussions with each Department Head, and analysis and review by the Treasurer and Village Manager. The tentative budget complies with the Property Tax Cap legislation; which this year has applied a tax base growth factor of 0.28%, an allowable levy growth factor of 1.15% and available carryover from FYE May 31, 2016 of \$186. This allows the Village to raise its tax levy to \$11,475,744 which is an increase from the prior year of \$161,884. The proposed tax rate for the tentative budget is \$257.182 per \$1,000 of assessed valuation. This represents an increase of \$1.897 per \$1,000 of assessed valuation resulting in a 0.74% increase in the tax rate. The proposed budget for 2017/2018 reflects an increase in Village Assessments of \$205,659.

Community Choice Aggregation

Village staff have met with Sustainable Westchester about the possibility of implementing a Community Choice Aggregation (CCA) program in Croton. This is a community-based bulk energy purchasing program intended to increase the use of renewable energy, provide a fixed rate in a volatile electric supply market and potentially lead to lower costs. It is known as an opt-in program, automatically enrolling all households into the program within the participating municipality; although, homeowners may opt-out of the program at any time by calling or emailing the electric supply provider. There are 20 municipalities throughout Westchester County participating in the current round of CCA, with the contract for the Con Ed territory, which includes Croton, set to expire next year. This provides an opportunity for the Village to join CCA in 2018. Sustainable Westchester has hired a PR firm and plans to assist the Village in implementing an informational marketing campaign to educate our residents about the program. There will be much more information provided about CCA in the months and year ahead.

Reminder!

Any utility bill (water and sewer) with a balance over 60 days will be added to the property owner's tax bill.

Elliott Way Update

The long awaited improvements to Elliott Way, including a new pedestrian walkway, are scheduled to begin this summer. The construction is expected to cause some traffic disruptions, and as such, residents are encouraged to access the park via the pedestrian bridge. More information about the project as well as subsequent changes to the traffic flow and pedestrian access will be disseminated by the Village as we approach the start of the project.

Sunset and **Gouveia Park Updates**

Construction of Sunset Park has been completed, but some weatherdependent landscaping work still remains. The Village will be planning a ribbon cutting ceremony on May 4, 2017 at 4pm, with the potential of opening the park before then. Further updates will be provided by the Village. Improvements to Gouveia Park continue, as there was a brief hiatus over the winter months. Work to widen the park's entrance and driveway, as well as the addition of a parking lot is set to be completed this spring so the park can be made available to the public for the summer.

Proposed Changes to Village Utility Billing

The Village is considering billing its utility customers

on a quarterly basis. The rationale for the change is that the increased billing periods will allow residents to more closely monitor their water consumption in an effort to identify and fix issues that could lead to higher than normal utility bills. Currently utility billing is done twice a year, which makes it difficult for residents to identify water leaks or high usage activities that can generate high utility bills over a 6 month period. A public hearing will be held on April 17, 2017 at 8pm in the Municipal Building.

Update on Treatment of Hvdrilla in the Croton River

The Village Board, Water Control Commission, Waterfront Advisory Committee, and staff have held meetings with NYS Department of Environmental Conservation (DEC) and NYC Department of Environmental Protection (DEP) regarding the treatment of the Croton River in order to eradicate Hydrilla, an invasive aquatic plant species. The NYS DEC has applied for a Village Wetlands Permit and other required permits to treat the Croton River with Fluridone, an aquatic herbicide approved by the Environmental Protection Agency. The Croton River will be treated from the base of the New Croton Dam to the point at which the Croton River meets the Hudson River. The Fluridone treatment is proposed to start in early June and continue for 90-120 days. A public information meeting was held in December 2016 and a second is scheduled some time in May 2017. Information will be disseminated to the public as it becomes available. In the meantime, if you have any questions please feel free to contact the Village Manager's office at 271-4848.
