Village Releases Tentative Budget for 2019-2020

Village Manager and Budget Officer Janine King filed the 2019-2020 tentative budget with the Village Clerk on March 18, 2019. This budget is the result of submissions from and discussions with each Department Head, and analysis and review by the Village Treasurer and Village Manager.

The budget, which is currently being reviewed by the Board of Trustees at budget work sessions (see calendar to the left), complies with the state property tax cap law. This year, a tax base growth factor of 0.28% has been applied, along with an allowable levy growth factor of 2% and an available carryover from FY 2017-2018 of \$173,682. This budget, as proposed, has a tax levy of \$11,721,287, which is \$277,916 less than the allowable limit and an increase of \$160,011 from last year.

The proposed tax rate is \$261.233 per \$1,000 of assessed valuation. This represents an increase of \$2.828 per \$1,000 of assessed valuation resulting in a 1.09% increase in the tax rate.

Croton Point Avenue Project Postponed

The Croton Point Avenue Bicycle & Pedestrian Improvement Project has been postponed for this year.

The Village released an Invitation to Bid on March I, 2019, for the project. This was the culmination of a multiyear effort between the Village and New York State DOT.

On March 29, 2019, the bid opening was held. A total of two bids were received from Billotta Construction Corp. and Montesano Bros. Inc.

Upon review by the Village and its consultant, the Village Board voted to reject the bids at their meeting of April 1, 2019. The reason for such rejection was due to higher than anticipated costs as well as the number of bids providing inadequate competition. This decision was not taken lightly, but the Village believes it to be in the best interest of the residents to rebid the project.

The Village is working with its engineering design consultant to analyze the bid package to ensure a future invitation to bid receives more responses. The Village tentatively expects to rebid the project in late 2019.



Demystifying Medicare for Seniors

This presentation is perfect for anyone trying to navigate their way through the complicated healthcare system. It will help those who already have Medicare, as well as people soon to be 65, planning their retirement, or assisting relatives and friends with their medical decisions.

The engaging, interactive program outlines the various parts of Medicare and lays out the costs associated with the medical and drug insurance provided by the government and private companies. Topics include Medicare Advantage Plans, prescription drug plans (Part D), Medigaps (supplemental plans) and various cost-saving programs.

The Village of Croton-on-Hudson DPW will be collecting yard waste curbside during the spring, summer and fall months (April through October). All yard waste must be placed in biodegradable leaf bags or open top garbage cans. Yard waste in plastic bags will not be collected. Yard waste put out with the garbage or mixed in with the garbage will not be collected. No more than ten bags or three open top garbage cans per pickup.

Yard waste will be collected:

- On the 1st & 3rd Wednesday of the month yard waste will be collected from homes North of Route 129
- On the 2nd & 4th Wednesday of the month yard waste will be collected from homes South of Route 129

What kind of yard waste can be put out for collection?

Raked up yard waste, small twigs, flowers, hedge trimmings may be placed in biodegradable yard waste bags. Small branches will be collected provided they meet the following criteria:

- I) Cut into lengths not to exceed 4 feet;
- 2) Tied into bundles not exceeding 18" in diameter;
- 3) Not more than two bundles of small branches per collection.

Grass clippings should be left on the lawn.

Zoning Study Survey

The Village hosted its first Zoning Update workshop on Thursday, March 21, at the Harmon Firehouse. At this workshop, representatives from the Village's planning consultant, BFJ Planning, identified the two areas which are to be studied, the Municipal Place Gateway Area and the North Riverside Avenue Corridor, and the current zoning of each. All residents have been invited to complete a survey on the zoning study. This survey is intended to gather input from a diverse range of people who live, work or own property in the Village of Croton-on-Hudson, on the key issues and opportunities for the two areas.

The survey should take approximately 5-10 minutes to complete. There are 19 questions, mostly multiple choice. All individual responses are confidential and will be tabulated and shared in summary form only.
