# Every year, the Board of Trustees meets as the Board of Assessors for

the purpose of evaluating property owners requests for a change in their property assessment. This is known as Grievance Day. This year, the Board will meet on Tuesday, February 18th to review applications from 4 to 8 PM in the Municipal Building. Applications for a tax adjustment must be completed and filed with the Village Assessor, Thomas Waitkins, prior to 4 PM on Grievance Day.

To help you understand whether you should file a tax grievance to reduce your residential property assessment, perform the following calculation: Divide your property's current assessed valuation by the 2020 Residential Assessment Ratio (RAR) which is .0334. The result will provide the estimated market value of the property.

For example, if your property is assessed at \$15,000, the 2020 RAR will yield a market value of \$449,101. This calculation may help you decide whether to file a grievance to try to lower the assessment. Commercial properties follow a different procedure.

#### Reminder: Sign Up for Paperless Billing

The Village Treasurer's Office reminds all residents that paperless billing is available for both the quarterly utility bills and the annual Village property tax bills.

The Village is happy to offer this service to residents as it has been a frequent request over the years. Residents can opt in to receive utility bills via email and tax bills via email. It is important to note that residents will no longer receive bills via US Mail if they sign up for paperless billing.

Residents can sign up by going to www.crotononhudson-ny.gov, clicking "Online Forms" and then clicking "Utility/Tax Bill Email Form" under the Village Treasurer section.

#### New York State Plastic Bag Ban

The New York State plastic bag ban goes into effect on March I, 2020. The legislation bans the provision of single-use, plastic carryout bags at any point of sale. Under the new law, garment bags, trash bags and any bags used to wrap or contain certain foods, such as fruits and sliced meats are exempt from the ban. New York joins California and Hawaii as the only states where single-use plastic bags are banned.

Here are some simple suggestions on how each of us can cut back our use of all plastics, not just bags:

- 1. Stop using plastic straws, even in restaurants. If a straw is a must, purchase a reusable stainless steel or glass straw.
- 2. Use reusable bags for all of your shopping: food, clothes, etc. (canvas is Eco friendly and lasts years).
- 3. Choose paper boxes or glass containers over plastic ones. Often, products like laundry detergent come in cardboard which is more easily recycled than plastic.
- 4. Reuse containers for storing leftovers.
- 5. Use a reusable bottle or mug for your beverages, even when ordering from a to-go shop.
- 6. Bring your own container for take-out or for your restaurant doggy-bag.
- 7. Pack your lunch in reusable containers and bags.
- 8. Use a razor with replaceable blades instead of a disposable razor.
- 9. Don't throw away those plastic bread bagsreuse them!



#### Ice Skating at Duck Pond

Weather permitting, there will be UNSU-PERVISED ice skating on the Duck Pond, Bungalow Road. The Recreation Department requires 6" (six inches) of ice for skating.

A GREEN FLAG indicates the ice is safe. A RED FLAG indicates it is unsafe and skating is not permitted. Even when the ice is safe, for your own protection, never go skating by yourself.
