Grievance Day Information

Every year, the Board of Trustees meets as the Board of Assessors for the purpose of evaluating property owners' requests for a change in their property assessment. This is known as Grievance Day.

This year, the Board will meet on Tuesday, February 16 to review applications from 4 to 8 PM via Zoom. Those wishing to apply for a tax adjustment are encouraged to speak with the Village Assessor, Thomas Waitkins, prior to Grievance Day.

To help you understand whether you should file a tax grievance to reduce your residential property assessment, perform the following calculation: Divide your property's current assessed valuation by the 2021 Residential Assessment Ratio (RAR), which is .0328. The result will provide the estimated market value of the property. For example, if your property is assessed at \$15,000, the 2021 RAR will yield a market value of \$457,317 (15,000/0.0328). This calculation may help you decide whether to file a grievance to try to lower the assessment. Commercial properties follow a different procedure.

COVID-19 Vaccine Rollout Information

As of January 12, 2021, New Yorkers in Phase Ia and segments of Phase Ib are eligible for the COVID-19 vaccine. All vaccinations are by appointment only. Eligible groups include doctors, nurses and health care workers, people age 65 and over, first responders, teachers, public transit workers, grocery store workers and public safety workers. New York State has clarified that immunocompromised individuals will be able to register in the next phase. They are working with the CDC to define the term.

To determine your eligibility, and to schedule an appointment, you are encouraged to use the state's eligibility tool: https://am-i-eligible.covid19vaccine.health.ny.gov/.

Police Reform Public Hearing Scheduled for February 22

The Village's Police Reform Task Force has been hard at work the past two months reviewing the data received from the community survey and the comments received during the public forums. At the February I, 2021, Village Board meeting, the draft plan developed by the task force will be submitted to the board members for their review.

On February 22, 2021, at 6 p.m., the Village Board will hold a special meeting for the purposes of opening a public hearing on the adoption of the draft reform plan. Interested members of the public are invited to join the public hearing via Zoom to voice any comments or questions they have regarding the draft plan.

The Village Board of Trustees will take any public comments received into consideration and adopt a final reform plan at their March 15, 2021, meeting. A certification of adoption will then be sent to the New York State Budget Director in accordance with the Governor's Executive Order 203.


