New Parking Permit System for Hastings Avenue and Young Avenue

On December 20th, 2021, the Board of Trustees passed Local Law No. 15 of 2021, which enacted a parking permit system along certain areas of Hastings Avenue and Young Avenue. This decision was made in response to feedback from residents who were unable to park near their homes, as visitors of the Croton-Harmon train station would often park along these streets.

The affected streets are as follows:

- Hastings Avenue, between Benedict Boulevard & Devon Avenue.
- Young Avenue, between Oneida Avenue & Benedict Boulevard.

Under this law, no person shall be permitted to park a vehicle Monday through Friday between the hours of 7:00 AM to 7:00 PM, excluding holidays, for more than two hours unless the vehicle displays a valid parking permit as issued by the Village.

Two free permits will be issued to families of these streets upon request, with additional permits costing \$10 each. Permits are to be affixed to the vehicle's rear bumper

Meet Croton's Newest Police Officer

January's Village Budget Process


Following the quarterly update in December, the Village now continues its budgeting process by reviewing the capital budget requests established by each department head. The Village Manager and Village Treasurer anticipate meeting with each department head to discuss and tweak each department's budget proposal.

The culmination of these requests will be compared to the projected non-tax revenues, which results in the calculation of the Tax Levy, Simultaneously, Treasurer Tucker remains acutely aware of the State's Tax Cap, which limits the increase of the Tax Levy from year-to-year to 2% unless the Board of Trustees passes a local law with the intention to exceed this limit. However, the Village has not exceeded the State Tax Cap in over five years.

This budget process is crafted in tandem with the Village's 8-Year Capital Plan. The Capital Plan mainly accounts for larger purchases; including infrastructural improvements and the purchase of heavy equipment such as construction vehicles. Annually, the Village revisits the plan to stay on course, as well as to make adjustments as time moves on. The

Capital Plan considers various funding sources such as grants, the issuance of debt, and contributions

from the General Fund.



Public Hearing to Regulate Leaf Blowers

On December 20th, 2021, the Board of Trustees scheduled a public hearing on Local Law Introductory No. 14 of 2021 to amend Chapter 160 of the Village Code, Noise, to establish regulations on gas-powered leaf blowers for January 18th, 2022, at 7:00 PM.

This public hearing will determine whether or not regulations should be imposed to limit the times of the year that gas-powered leaf blowers can be utilized in certain areas of the Village.

Interested members of the public are invited to join the public hearing to voice any comments or questions they may have. Meeting location to be determined.

Westchester County Free PCR Tests

Westchester County is offering free PCR COVID-19 testing at the Westchester County Center. This testing is appointment only – walk-ins will not be accepted. Appointments will only be available three days in advance of the test date. For example, appointments for January 3rd would not be available to schedule until December 31st.

No Heat Complaints

Residents who live in rental units within the Village boundaries who experience no heat issues should contact the Village Code Enforcement Dept. during regular office hours from 8:30 AM to 4 PM at 271-4783. If the situation occurs outside of office hours, contact the Police Dept. at 271-5177.

Code enforcement personnel will visit the location to measure the temperature and contact the owners as necessary.

This applies to all rentals, including two-family houses, where the owner does not live on-site.

Veteran Tax Exemptions Increased

New York State has increased the allowable amounts for veteran's exemptions including non-combat, combat and disabled veterans.

At the recommendation of Assessor Thomas Waitkins, the Board of Trustees agreed to increase these exemptions by adopting Local Law No. 14 of 2021 to amend Chapter 204 of the Village Code.

Additionally, the Cold War Veterans exemption, which was scheduled to sunset this year, has been extended permanently.

Lindsay Audin Inducted Into Westchester County Senior Hall of Fame

On December 3rd, Village resident and Croton's Sustainability Committee Chair, Lindsay Audin was inducted into the Westchester County Senior Hall of Fame. Now in its 39th year, the Senior Hall of Fame exists to celebrate remarkable senior citizens in Westchester County and acknowledge their contributions to others. To date, over 1,100 senior citizens have been inducted to the hall of fame.

Lindsay Audin first became Croton's Sustainability Committee Chair in 2015. In that position, he secured Croton-on-Hudson its silver CSC certification, and one of the highest CEC point scores in the State. In 2021, his efforts secured \$110,000 in State grants for projects that will cut the Village's operating costs and carbon footprint at no cost to Village taxpayers.
