North Riverside Corridor/Municipal Place Gateway Zoning Study Update

The Village has concluded the zoning survey which was released to all residents and property owners in March. Over 1,400 surveys were submitted and the Village would like to thank everyone who took time to either complete the survey online or return one to the Municipal Building.

The Village's planning consultant, BFJ Planning, is analyzing and tabulating the results, and will be presenting this information at the second zoning workshop.

The geographic scope of the study primarily includes a) the Municipal Place Gateway zoning area (zoned mostly C-2) and b) the stretch of Riverside from the SE corner of Grand Street north to the former Zoller's site. (zoned C-1). The characteristics of C-1 and C-2 zoning districts are similar in that they both currently allow buildings of 2 ½ stories and 35 feet in height as of right. They differ in the allowable bulk of a building (how much space it uses up) on each site as well as allowable uses. Mixed use is allowed by Special Permit in both.

The Zoning study is looking at whether these existing zoning parameters are still the best fit for these two areas. Are there any issues with the existing zoning in these areas that might be improved? Survey questions sought input on aesthetics, walkability, parking, green space, etc. in these areas as well as potential uses.

All residents and property owners are encouraged to attend the second zoning workshop on Tuesday, June 18, at the Harmon Firehouse at 7:30 PM.

At this meeting, individual areas and topics will be discussed in multiple break-out sessions giving participants an opportunity to provide additional thoughts and input. Following these sessions and the survey results, recommendations will be suggested by BFJ for further review and input.

For those who provided their email address on the survey, reminders of this workshop will be sent on the Village's e-Alerts system.

Police Department Memo on Dogs

The Croton Police Department would like to remind all residents about the Village's regulations on dogs. All dogs over the age of four months are required to be licensed per New York State law. Dog license applications are available at the Municipal Building.

All dogs are required to be on-leash at all times unless on private property or within the fenced-in dog park at Black Rock Park. Dogs are prohibited in all Village parks, with the exception of Black Rock Park and the Riverwalk Trail at Croton Landing Park. Owners must also curb their dogs while walking.

Park rangers have begun work for the summer season and will be actively enforcing the above provisions. The Village thanks all residents in advance for their cooperation with the above!

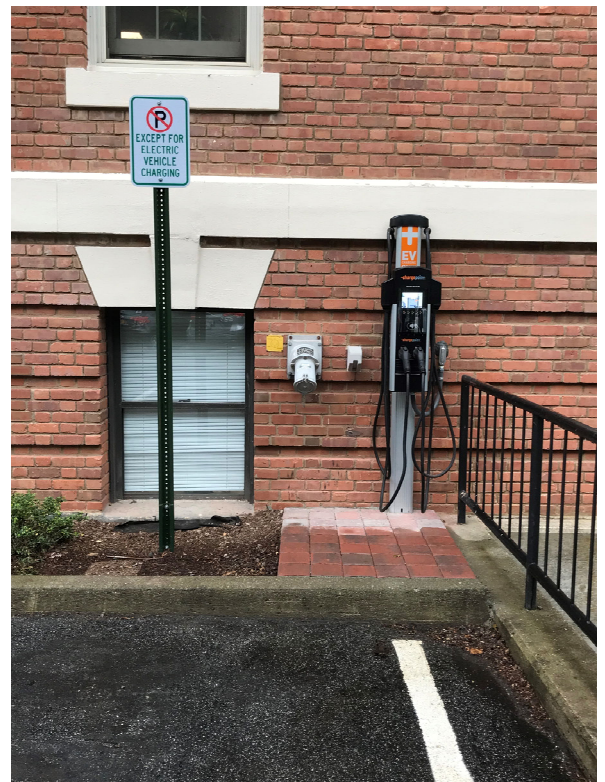
Village Installs Electric Vehicle Charging Stations

The Village of Croton-on-Hudson has recently installed two electric vehicle charging stations at the Municipal Building. One station has been reserved for use by official vehicles and is marked as such. The other station (able to charge two cars at once) is available for public use.

Any resident interested in using the charging station should first download the ChargePoint mobile app, which is used to pay for the charge. Once you arrive at the Municipal Building, please park in one of the two public charging spaces and follow the instructions on the charging station screen. Please note that these spaces have a time limit parking of four hours.

The DPW is working to install an additional charging station at Lot F in the Croton-Harmon Train Station parking lot, which will be available for commuter use.

Sidewalk Replacement Program

The Village's new sidewalk replacement program begins on June 1. The program, adopted by the Village Board of Trustees on March 4th, requires a 60% contribution from the property owner. The Village will contribute the remaining 40% of the actual cost for the removal and replacement of sidewalks, including materials and labor for the repairs & reconstruction.

This program is available to property owners with existing sidewalks, as well as those who no longer have a sidewalk but can document a sidewalk previously existed on their property.

Residents who are interested in having their sidewalk replaced should contact the Village Engineer's Office at 914-271-4783 to find out more about the application process.

2020 Census Committee

The Village has established a complete count committee to ensure all residents are properly counted in the 2020 U.S. Census. This committee, known as Be Counted in Croton (BCIC), has been meeting informally since last summer to develop plans and procedures to reach all residents of the Village.

The committee will be making a presentation at the June 17th Board of Trustees meeting to discuss what some of these plans may involve, as well as discuss the importance of being counted.

The U.S. Census Bureau will be represented at Summerfest - be sure to visit their table near the dummy light on Sunday, June 2nd!
