

A **General Election** will be held on Tuesday, November 8th, 2022 from 6 a.m. to 9 p.m. Westchester County registered voters are eligible to cast an early voting ballot. The Early Voting period for the November 8, 2022 General Election will be from Saturday, Oct. 29th, 2022 through Sunday, Nov. 6th, 2022. Please note that Early Voting locations and times differ from Election Day.

# Croton River Hydrilla Treatment Project Successfully Completed

On October 17th, the NYS Department of Environmental Conservation marked the completion of a multi-year treatment of **hydrilla**, an aggressive invasive species that poses significant threats to water quality and habitat at Croton River. In 2016, 46% of the Croton River was infested with hydrilla. This year, NO hydrilla was detected. **Trustees Ann Gallelli** and **Len Simon** joined NYS DEC Regional Director Kelly Turturro and partners at Croton Gorge Park to celebrate the success of this long-term invasive species control effort on the Croton River.

### Croton Police Add Three School Resource Officers to Ranks

The Croton Police Department is pleased to announce that three of its members have been trained as **School Resource Officers** (SROs). SROs are police officers who undergo specialized training to work in a school setting. SROs can fulfill a variety of roles, including preventing and responding to school-based crime, and fostering positive relationships among law enforcement, educators, and youth. **Croton Police Chief Nikitopoulos** says the SRO training is a proactive way to strengthen relations between the Police Department and the school community they serve.

#### **Income Eligibility Raised for Senior Property Tax Exemption**

The Village of Croton-on-Hudson recently adopted a local law to increase the income eligibility for the **senior property tax exemption** from \$29,000 to \$50,000/year or less. In order to receive the exemption, residents must file an application with the Village Assessor each year. The deadline for submitting an application is **December 31st.** To qualify for the exemption, seniors must meet certain residency, age, income, and ownership requirements.
