# <u>Update on North Riverside Avenue/</u> <u>Municipal Place Gateway Area Zoning Study</u>

Work has continued over the summer months on the proposed zoning updates for the North Riverside Avenue and Municipal Place Gateway areas.

The Village Board will be holding a work session on September 9th to review the final report from BFJ Planning, the Village's zoning consultant. The report reflects the input received from two public input sessions, survey results and the zoning study working group. As part of the review of the BFJ report, the Board will be discussing the firm's recommendations regarding proposed amendments to the zoning code.

While there is no public comment period at the Board work sessions, the public will have additional opportunities to discuss the recommendations and proposed zoning amendments. Any amendments to the zoning code require the Village to follow the rules of the State Environmental

Quality Review Act (SEQRA). The Village Board plans to declare itself Lead Agency under SEQRA at the September 16th Board meeting. Additionally, the Board plans to refer the proposed zoning amendments to the Village Planning Board and Waterfront Advisory Committee for their review and comment, as required by Village law. The proposal must also be referred to the Westchester County Planning Board for review and comment. Once all three agencies have returned their comments to the Village Board, a Public Hearing will be scheduled and will remain open until all interested residents have had the opportunity to comment.

# **Croton Point Avenue Project Update**

The Village has been moving forward to rebid the Croton Point Avenue project this fall. In an effort to help streamline the bid package and move the project forward, the Village has decided to undertake some items included in the previous bid. These include the lighting underneath the Route 9 overpass, electric pole relocation by Con Edison and water main improvements along Croton Point Avenue.

By doing these projects independently of the main project, it is hoped that the new bids received in the fall will be in line with funding estimates. The Village plans to rebid the project in October 2019 and award the bid by the end of the year. Work would then commence in Spring 2020.

#### **BCC September 11th Ceremony**

The annual 9-11 Memorial Ceremony will be held on Wednesday, September 11 at 4:30 PM at Croton Landing. The ceremony is jointly held by the Town of Cortlandt, and Villages of Buchanan and Croton-on-Hudson.

To attend the ceremony, please gather at the Croton Landing parking area at the north end of Elliott Way by 4 PM. Led by a color guard from the community, participants will walk in procession along the quarter mile pathway north to the memorial site on the Hudson River.

A van from the Village of Croton will be in the parking area to transport those who need assistance.

# **Village Board Adopts Idling Fine**

At the August 12th Village Board meeting, the Board adopted a \$35 fine for anyone found to be idling a vehicle in excess of three minutes. Westchester County adopted an anti-idling law in 2009 which restricts the time, place and manner in which vehicles are allowed to idle.

As such, the Village Manager has introduced an amendment to the Vehicle & Traffic section of the Village Code to prohibit idling in excess of three minutes whenever the air temperature is above 32 degrees Fahrenheit. The idling law applies to any vehicle found to be parked, standing or stopped, as these words are defined in the Vehicle & Traffic Law of New York State. Emergency vehicles are exempt from the provisions of the idling law.

The provisions of the law will take effect on September 29, 2019. Until that time, police officers and parking enforcement officers will be issuing warnings to vehicles found violating the idling law.
