The facts upon which is instrument is based are as follows:

Mark Franzoso having received approval from the Planning Board and a building permit to start the construction of a single-family house at 32 Piney Point Avenue did commence construction of the single-family house and associated site improvements. The approval from the Planning Board included a limit of disturbance on the site plans. The limit of disturbance was established to limit disturbance of steep slopes to an amount below the threshold in the Village's Steep Slope Protection Law which if exceeded required the issuance of a Steep Slope Permit by the Planning Board. An inspection on September 4, 2019 showed that areas of steep slope outside of the approved limit of disturbance was disturbed resulting in the total steep slope disturbance exceeding the threshold that requires the issuance of a steep slope permit. The defendant did disturb additional areas of steep slope outside the approved limit of disturbance without a steep slope permit in violation of section 230-174(A) of Chapter 230, Zoning, of the Code of the Village of Croton-on-Hudson.
