Dear Riparian Property Owner/User:

The New York State Department of Environmental Conservation (NYSDEC) is currently conducting an application of the aquatic herbicide fluridone (Sonar Genesis) to control the growth and spread of the highly invasive aquatic plant species *Hydrilla verticillata* in the Croton River. Hydrilla is a federally listed noxious weed and a prohibited species in New York.

We have chosen a method of control that allows for use of a low concentration of herbicide (2-4 parts per billion). Protocol for treatment and many other project details can be found on the project webpage http://www.dec.ny.gov/animals/106386.html NYSDEC is carefully monitoring the concentration of herbicide throughout the Croton River during the treatment to determine that the effective concentration is being maintained. In addition, aquatic plants and macroinvertebrates are being monitored for impacts. We are also working closely with NYSDEC Region 3 Bureau of Fisheries to ensure that habitat impacts are minimal and temporary.

The treatment is being carried out by SOLitude Lake Management, licensed applicators registered with the New York State Department of Environmental Conservation (#16506). NYSDEC Aquatic Pesticide Permit for the application of the herbicide fluridone (Sonar Genesis) was issued on May 11, 2018 (Permit AV-3-18-505). Treatment began June 6, 2018 and was scheduled to continue until October 31, 2018. Due to multiple rain events and high flows in the Croton River the herbicide treatment has been suspended several times. In order to meet the recommended number of days of treatment we have been given permission to extend the treatment period to November 15, 2018.

Signs will remain in public areas during application. Label water use restrictions at applied herbicide concentrations (2-4 ppb) are as follows:
