### **Conditions of Approval**

- 1) This permit is only valid from \_\_\_\_\_ through \_\_\_\_\_
- 2) The dumpster/pod shall be placed as far as possible outside the traffic lane.
- 3) Traffic caution devices (cones, etc.) shall be installed on both sides of the dumpster/pod.
- 4) The dumpster/pod shall not be placed in a location that would significantly reduce sight distances.
- 5) That a protective layer of wood be installed between the dumpster/Pod bearing point and the ground surface.
- 6) That the dumpster be removed within 24 hours of full capacity or the end of the removal/demolition work or permitted end date whichever is sooner.
- 7) That after removal of the dumpster/pod, all trash and litter shall be removed, and the street swept and any damage to surfaces repaired.
- 8) That any additional requirements from the Village Engineer or Superintendent of DPW shall be part of this permit.
- 9) The Village may require the dumpster/pod to be removed if there is 2" or more of snow to allow for Village plowing.
