RE: Quarterly Report – Manager's Office

For the fourth quarter period of FY 2018-19, the Manager's Office has been continuing to grow its online repository of records and forms, as well as the Village's social media presence.

As of May 31, the following were received during the third quarter via SeamlessDocs:

All total, the Village received a total of 506 online submissions via SeamlessDocs in the fourth quarter of 2018-2019, a 19% increase over the third quarter of the year. During the fourth quarter, the Village expanded the use of SeamlessDocs for recreation programs such as Kite Day and the Eggstravaganza. Additionally, residents are permitted to register their vehicles for weekend parking stickers online, which has proven to be very popular. The Village, by way of absorbing Summerfest, also provided online registration to vendors for the first time. During the new fiscal year, we will be looking to add more internal forms to SeamlessDocs, such as the leave request forms.

On our social media and communication front, the Village continues to post gains, albeit at slower rates than previous quarters. The following were our statistics at the beginning and end of the quarter:

The Village currently has 11 email subscriptions available to residents to keep abreast of village news and information. The total subscribers for each of these subscriptions is as follows:

These increases can be partially attributed to the strong response to the Village's zoning survey, as well as residual responses to the e-newsletter campaign. The Manager's Office will be continuing its efforts to increase subscribers to the E-Alerts system through the next fiscal year.

The Village sent out a total of 53 emails on the village news, 26 emails on the agenda lists, 3 snow alert emails, 11 emails on the recreation list, 3 emails on the seniors list and 3 newsletter emails during the period between March and May 2019. This averages out to slightly more than one email a day, which is part of our goal to not overcrowd subscriber's email inboxes.

The Village Manager's office also compiled three newsletters during this period, which went out in March, April and May. The newsletter is now being delivered to over 2400 individuals via email and about 550 via U.S. Mail. A limited supply of newsletters are printed and available at the office counter and library, as well.

During the fourth quarter of the fiscal year, the Village Board held a total of six regular meetings and ten work sessions. A total of 52 resolutions were adopted by the board.
